**Tour Prices:** All rates are based on tariffs and exchanges in effect on October 1, 2010. Livonia Travel Service, Inc. reserves the right to adjust prices in case of rate of exchange increases and airline tax, fuel surcharge increases, up until the time full payment is received.

**Reservation, Deposit and Final Payment:** A \$500 per person deposit is required to make reservations, along with a signed copy of the registration form. Final payment is due by January 20, 2010. Late payments are subject to a \$50.00 handling charge. Late registration (within sixty-five days prior to departure) requires a full payment by cashier check and is subject to availability. All checks should be made payable to Livonia Travel Service, Inc.

**Cancellation fees:** \$500 per person cancellation fee will apply from the time of reservation. From Jan 20 to Mar 21: 100% of Tour Package price (no refund). Cancellation is only accepted in writing. Trip cancellation insurance is available and highly recommended. Please ask for a free quote.
